

(USMX); the Port of New York and New Jersey Sustainable Services Agreement (PONYNJSSA); and the Port of NY/NJ—Port Authority/Marine Terminal Operator Agreement (PAMTOA) with regard to the submission of comments to the above-referenced docket. USMX, PONYNJSSA and PAMTOA are responding to the Petition for Leave to Supplement the Record filed by The Coalition for Fair Port Practices (Petition to Supplement) in the above-referenced docket.

USMX, PONYNJSSA, and PAMTOA have submitted comments on the Petition that initiated this docket. USMX, PONYNJSSA, and PAMTOA have read the Response and Opposition of the World Shipping Council (WSC) to the Petitioners' Petition for Leave to Supplement Record dated April 6, 2017 and submitted to the agency. USMX, PONYNJSSA, and PAMTOA endorse and adopt the positions taken and arguments made therein as if fully restated herein.

Notwithstanding its other procedural defects, the Petition to Supplement did not provide any new information to assist the agency in its review of the initial Petition; it merely attempts to rebut the legal arguments made by organizations opposing the Petition. The Coalition for Fair Port Practices is seeking to replace the agency's analysis of the information it has been provided during the prescribed comment period with its own assessment of the applicable law. For these and for the reasons asserted by the WSC, the FMC should deny the Petition to Supplement.


